
On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

- 2** *Section 6 (1) is amended by striking out “115 days” and substituting “90 days”.*
- 3** *Section 7 is amended*
 - (a) in subsection (1) by striking out “90 days” and substituting “75 days”,*
 - (b) in subsection (4) (c) by striking out “member before” and substituting “commissioner before”, and*
 - (c) in subsection (6) by striking out “85 days” and substituting “70 days”.*
- 4** *Section 8 (2) is amended*
 - (a) by striking out “section 7 (1)” and substituting “section 7 (1) (a)”, and*
 - (b) by striking out “75th day” and substituting “60th day”.*
- 5** *Sections 9 and 10 (1) are amended by striking out “40 days” and substituting “30 days”.*
- 6** *Section 16 is amended*
 - (a) in subsection (1) by adding “and of the election day for the by-election” after “notice of a by-election”, and*
 - (b) by adding the following subsection:*
 - (5.1) On election day for the by-election, the secrétaire trésorier must declare the results of the election.*
- 7** *Section 18 (2) is amended by striking out “declaration of official results under section 14” and substituting “declaration of the results of the election”.*
- 8** *Section 19.4 (1) (a) is amended by striking out “90 days” and substituting “75 days”.*
- 9** *Schedule C is amended*
 - (a) in the Oath of Office by striking out the following:*
