Dear Minister Bains,

Please find in the attached a letter from the President of the Conseil Scolaire Francophone (CSF), British Columbia's Francophone School Board regarding inadequate collection of data by Statistics Canada. This shortcoming results in faulty enumeration of minority language rights holders, and negative impacts on supply of education.

The CSF concerns regarding rights holders' census enumeration were confirmed by the May 2017 report tabled by the Standing Committee on Official Languages.

According to Chairperson Lavoie, current data collection excludes Francophones whose mother tongue is not French but were or had their children educated in French. As a result, schools built following census numbers underestimate the number of students and limit both the community of Francophones and its school board serving British Columbians.

Please ensure that Statistics Canada's 2021 census enumerates all rights-holders, and upholds the BC Francophone community's educational rights guaranteed under section 23 of the Canadian Charter of Rights and Freedoms.
